

BOROUGH OF SWARTHMORE  
ORDINANCE 1080

AN ORDINANCE OF THE BOROUGH OF SWARTHMORE AMENDING  
CHAPTER 440 OF THE CODIFIED ORDINANCES OF THE BOROUGH  
RELATED TO PARKING

The Borough Council of the Borough of Swarthmore hereby enacts  
and ordains as follows:

Section 1: Parking Prohibited

Section 440.02 of the Codified Ordinances of the Borough of  
Swarthmore is hereby amended to prohibit parking from 7 a.m. to  
5 p.m., Monday through Friday at the following locations:

- Dartmouth Avenue, on the south side, between Lafayette  
Avenue and Oberlin Avenue
- Cornell Avenue, on the east side, between Harvard Avenue  
and Yale Avenue
- Harvard Avenue, on the north side, between Chester Road and  
Yale Avenue

Section 2: Residents Exempted

Borough residents in possession of a resident parking sticker  
issued in compliance with Section 440.08 of the Codified  
Ordinances of the Borough of Swarthmore shall be exempt from  
parking restrictions at the following locations:

- Dartmouth Avenue, on the south side, between Lafayette  
Avenue and Oberlin Avenue
- Cornell Avenue, on the west side, between Harvard Avenue  
and Yale Avenue
- Harvard Avenue, on the north side, between Chester Road and  
Yale Avenue

Section 3: Severability

The provisions of this ordinance are severable, and if any  
section, sentence, clause, part, or provision hereof shall be  
held illegal, invalid or unconstitutional by any court of  
competent jurisdiction, such decision of the court shall not  
affect or impair the remaining sections, sentences, clauses, or  
parts of this Ordinance. It is hereby declared to be the intent  
of the Borough Council that this Ordinance would have been  
adopted if such illegal, invalid, or unconstitutional sections,  
sentence, clause, part, or provision had not been included  
therein.

Section 4: Repealer

All resolutions or ordinances, or parts thereof, that are inconsistent herewith are hereby repealed to the extent of the inconsistency.

Section 5: Adoption.

This Ordinance shall take effect and be in force from and after its enactment as required by law.
